**Notification for Election of one M.C.I. Member from Chhattisgarh State**


Whereas one member is to be elected from amongst the Medical Practitioners of Chhattisgarh State to the Medical Council of India, under section 3(1) (C) of the Indian Medical Council Act, 1956, I, Director Medical Education, State of Chhattisgarh, Raipur, who is the Returning Officer, for the same, request all Medical Practitioners who are registered with Chhattisgarh Medical Council in the category of Medical Graduates of Indian or recognized Foreign Universities whose qualifications are included in the First or Second or in part II of the Third Schedule, to the Indian Medical Council Act, 1956, to elect a member from amongst them.

Copies of Medical Registers will be available at the Directorate of Medical Education, Old Nurses Hostel, D.K.S.Bhawan Parisar, Raipur and shall be open to inspection during office hours i.e. from 11 AM to 5.30 PM on working days. Copies of Medical register will also be available on the website of Chhattisgarh Medical Council [www.cgmedicalcouncil.org](http://www.cgmedicalcouncil.org), Directorate of Medical Education [www.cgdme.co.in](http://www.cgdme.co.in) and Department of health and family welfare [www.cghealth.nic.in](http://www.cghealth.nic.in)

Any person, registered amongst Graduates of Indian or recognized Foreign Universities whose qualifications are included in the First or second or in part II of the Third Schedule to the Indian Medical Council Act, 1956, whose name is also entered in Indian Medical register and who is a citizen of India, can be nominated as a candidate for the election. Such nomination shall be made by mean of a nomination paper in a prescribed form which will be supplied by the Returning Officer to any candidate who applies for it at the office of Directorate of Medical Education, Old Nurses Hostel, D.K.S. Bhawan Parisar, Raipur- 492001 (C.G.). - 25 Sep.2018**, 5 PM as the last date for receipt of nomination papers, and upto 28 Sep.2018, 12 noon for withdrawal for nomination and scrutiny of nomination papers.
- 29 Sep.2018** publication of final list of candidates for election.
- 03 Oct.2018** will be the last date for registering objection.
- 08 Oct.2018** for dispatch of voting papers to all registered medical practitioner.
- 23 Oct.2018** for the Poll voting papers to reach the Returning Officer not later than 5 PM on that date.
- 24 Oct.2018**, 12 noon for scrutiny and counting of votes and declaration of result, at the Lecture hall No.6, Pt.J.N.M.Medical College, Raipur (C.G.)
