RULES FOR COUTINUING MEDICAL EDUCATION (CME)

Medical Science is Dynamic and there is no end of learning for a doctor. This is in essence the Concept of continuing medical education (CME).

Following are the rules of CME and modalities for accreditation:-

All State level organizations conducting CME programmers at present should approach the C.G. Medical Council for accreditation of these organization.

On receipt of Such request, C.G. Medical Council shall consider the following factors for being granted accreditation for conducting CME programmes and shall award credit hours:-

- 1- CME programmers meant for graduate should have a brief session on National Health Programs on relevant subject along with adequate exposure to recent advances, changing modalities of treatment, adequate exposure of consumer protection and medical insurance laws, record keeping and medical audit.
- 2- The organization should have all the requisite and demonstrated group (General Practitioners & specialists medical teachers (and Vertical National Health program officials) etc.
- 3- The organization should provide the schedule and transcripts of each C.M.E activity.
- 4- Organizations should make arrangements for advance publicity to the targeted group of participants .
- 5- The methodology of feedback evaluation program should be intimated in advance.
- 6- The organization should undertake to publish handouts, bring out a brief of each CME and also prepare a list of participants and sent it to C.G. Medical Council immediately after the CME program.
- 7- The transcript of knowledge of the medical practitioners by way of latest medical advances, National Health Program, and the local needs of the Area/Zone/State.
- 8- The resource personnel should be experienced enough in providing the CME programs.
- 9- The organization should evaluate CME to indicate the benefits accrued to participants by way of updating of knowledge, upgrading their ability and benefit to the patients.

10- Accreditation shall be for a period of five years. After 5 year renewal will be done for a further five year. Accreditation may be cancelled for valid reasons.

Registers to be maintained by the Medical Councils

C.G. Medical Council shall maintain a register (Computer data based) showing the names of accredited organization conducting CME programs.

Keeping in view large volume of work to be handled by the Council in regard to approval of organizations conduction the CME course, keeping record of CME programs attended each year by registered medical practitioners and coordination with Sate Medical Councils etc. a separate section is created for the purpose.

GUIDELINES FOR C.M.E. ACCREDITATION

- 1- Accreditation/ Credit hours to be awarded awarded will be the Sole discretion of the C.G. Medical Council and will depend upon the Subject matter, Status of the Speaker, Quality of the papers to be presented in the C.M.E./Conference.
- 2- Any professional organization or body or institution making to hold CME's should apply for accreditation to the C.G. Medical Council . The council on verifying the credentials of the organization will give certificate on verifying to those bodies to hold CME's.
- 3- The office bearers to the Association / Organization will apply to the C.G. Medical Council on a designed application form. The application should be accompanied by the complete programme of the C.M.E. /Conference including the names, designation, area of specialization and Country of the

Speakers and the Subject of speech.

- 4- Accredited bodies like I.M.A./ professional bodies which hold regular CME's will have to infrom the C.G. Medical Council . the date &time of the CME, at least 15 days in advance.
- 5- In the application sent to the C.G. Medical Council, duration given to each Speaker Should also be mentioned along with the topic to the lecturer While applying for the credit hours.
- 6- Credit hours will be based on the composition of the faculty participation, quality and the contents of the subject matter.
- 7- Associations/Organization Should strictly issue the certificate to the delegate who has attended the CME. No certificates Should be distributed on the first day at the time of Registration for the CME/Conference . The certificates should be distributed/awarded only on the last day after completion of CMC/Conference /Workshop.
- 8- Associations/Organizations will be duty bound to send the feedback of the delegate and the list of the delegates who have attended the CME/Conference. A separate list for the delegates belonging to State of Chhattisgarh and delegates of the other states be submitted to the C.G. Medical Council.
- 9- in case it is found by the council that the certificate is false then the accreditation certificate of issuing Association/Organization will be cancelled.

Guidelines for credit hours

- 1- Guest Lecture (of 60 minutes duration) by foreign faculty of international repute shall be eligible for one credit hour.
- 2- CME/Workshop of minimum three hours duration shall be eligible for one credit hour.
- 3- CME/workshop of six hours duration shall be eligible for two credit hour.
- 4- Presently many associations of doctors are organizing international conferences/CME/Workshop in Chhattisgarh.
- C.G. Medical Council will recognize international status of conference. If ten or more than ten faculty members from abroad are participating as faculty in such Conferences.

The credit hours for delegates attending such Conferences/CME/Workshop will be as below.

Sr. No. Credit Hours

1) one day C.M.E.?workshop/Conferences

4 Hours

2) Half day C.M.E.?workshop/Conferences

2 Hours

Faculty Members of international conferences will get one addition credit Hours.

- 5- Speakers at any conference/CME/Workshop/Training program will be given one credit hours in addition to the credit hours allotted to delegates for that particular academic activity.
- 6- Director. Joint director ,medical education & research/Director, Joint director health services and Deans of Medical Collages will be awarded 4Credit hours per year. They will have to produce certificate to C.G. Medical Council regarding their job status
- 7- Doctors working as medial teachers can claim 4 Credit hours per year after producing certificate from
 Theirhead of indicating that are taking undergraduate/postgraduate clases & are engaged in their
 head of institution indicating that, they are taking undergraduate/postgraduate classes & are engaged in
 postgraduate, research work.
- 8- Doctors doing Post Graduate Courses e.g. Diploma (University/C.P.S. Mumbai), M.D., M.S., D.N.B., M.Ch., D.M., (and other PG. Courses in abroad) etc. from recognized/reputed institution will get

4credit hours per year for the duration of the course. E.g. First year 4 credit hour. Second Years 4 credit hour, third year 4 credit hour.

- 9- The doctors may attend the international C.M.E.'s/ Conferences held overseas as delegates. On the production of the certificates attendance. CME credit hours will be given.
- 10- Any paper published in index National/International Medical Journal will entitle the author/co-author for credit hours.
- 11- any chapter published in a text book or update book published by professional bodies will entitle the author /co-authors for credit hours.
- 12- Participation in on line medical education module (for one hour duration) C.G. Medical Council will grant one credit hour.

RMP's Who will complete course in online medical Education Module Should print certificate stating CME. Credit hours, CME credit hours, C.G. Medical Council will recognize these credit hour.

13- Credit hour certificate of CME/Workshop /National /International Conference will be signed by Registrar C.G. Medical Council.

Sir /Madam,

Your kind attention is invited to section 14(1) of the Indian Medical Council Act, 1956 which reads as under:-

- 1. The Central Government after consultation with the Council, may, by notification in the Official Gazette, direct that medical qualification granted by medical institutions in any country out -side India in respect of which a scheme of reciprocity for the recognition of medical qualification is not in force, shall be recognized medical qualification for the purposes of this Act or shall be so only when granted after a specified date: provide that medical practice by persons possessing such qualifications:-
- a. Shall be permitted only if such persons are enrolled as medical practitioners in accordance with the law regulating the registration of medical practitioners for the time being in force in that country:
- b. shall be Limited to the institution to which they are attached for the time being for the purposes of teaching, research or charitable work; and
- c. shall be Limited to the institution to period specified in this behalf by the Central Government by general or special order.

In view of the above, you are requested to ensure that all the Foreign Nationals/NRI faculty will have to take prior permission from the Medical Council of India if he/she demonstrates/conducts any procedure, intervention, surgery, drug therapy, application of any new device or any treatment, on a patient in any CME programmes/workshop/postgraduate courses or any other medical organization in India.

This is mandatory and suo-moto action would be initiated by Medical Council of India against the erring medical college/institution.
